

## TERMS OF SERVICE

### 1. INTRODUCTION AND ACCEPTANCE

Welcome to TradersKE ('Company', 'we', 'us', 'our'). By accessing or using our website at [www.traderske.com](http://www.traderske.com), our Discord community, Telegram channel, WhatsApp channel, coaching services, events, merchandise store, or any other services we provide (collectively, the 'Services'), you agree to be bound by these Terms of Service ('Terms'). If you do not agree to these Terms, please do not use our Services.

These Terms constitute a legally binding agreement between you and TradersKE, a community-based forex education and trade ideas service operating in Kenya. We reserve the right to update these Terms at any time. Continued use of our Services following notice of changes constitutes acceptance of the updated Terms.

### 2. DESCRIPTION OF SERVICES

TradersKE provides the following services to its members:

- Forex trade ideas and market analysis delivered via Discord, Telegram and WhatsApp
- 1-on-1 coaching and mentorship sessions conducted via Zoom/Google meet
- Live events, bootcamps and in-person meetups in Nairobi and online
- Educational content covering forex trading, risk management, and market psychology
- Branded merchandise available for purchase via our website & WhatsApp
- Prop firm guidance and challenge preparation resources

All content, trade ideas, and analysis provided by TradersKE are for EDUCATIONAL AND INFORMATIONAL PURPOSES ONLY. Nothing we publish constitutes financial advice, investment advice, or a solicitation to trade.

### **3. ELIGIBILITY AND ACCOUNT REGISTRATION**

#### **3.1 Age Requirement**

You must be at least 18 years of age to use our Services. By using our Services, you represent and warrant that you meet this age requirement.

#### **3.2 Accuracy of Information**

When registering or booking sessions, you agree to provide accurate, current, and complete information. You are responsible for maintaining the confidentiality of any account credentials and for all activities that occur under your account.

#### **3.3 Prohibited Users**

Our Services are not available to persons previously banned from our community, or to persons residing in jurisdictions where forex trading education services are prohibited by law.

## 4. PAYMENT TERMS

### 4.1 Pricing

All prices are displayed on our website and are subject to change. Prices may be listed in USD or KES. The applicable exchange rate at time of payment applies.

### 4.2 Payment Methods

We accept payment via M-Pesa (Send Money to our registered Till number). By making a payment, you confirm that you are authorised to use the payment method provided and that the payment information is accurate.

### 4.3 Discord Membership

Discord lifetime membership is a one-time payment granting permanent access to our premium Discord server. THIS ACCESS MAY BE REVOKED IF YOU VIOLATE OUR COMMUNITY GUIDELINES OR THESE TERMS.

### 4.4 Coaching Sessions

Coaching sessions must be paid in full before the session commences. Sessions not attended without 24-hour notice of cancellation are forfeited. Rescheduling is permitted with at least 12 hours notice and is subject to availability.

### 4.5 Events

Free events require registration with a qualifying HFM live account. Paid event tickets are non-refundable unless the event is cancelled by TradersKE. Spot limits apply and registration is first-come, first-served.

All members are expected to uphold The TradersKE Standard.

### 1. CORE VALUES

- Real trading over fake lifestyles — we do not tolerate fake screenshots or inflated claims
- Skill development over shortcuts — we educate, not promise get-rich-quick results
- Transparency over hype — honest analysis, including losses, is valued
- Discipline over emotions — we support each other through drawdowns and difficult periods

### 2. RESPECT AND CONDUCT

All members must treat each other and TradersKE staff with respect. The following are strictly prohibited:

- Personal attacks, insults, or harassment of any member
- **SCAM MESSAGES, PHISHING LINKS, OR FRAUDULENT INVESTMENT SCHEMES**
- Discriminatory language based on race, gender, nationality, religion, or any other characteristic
- Threatening or intimidating behaviour
- Publicly calling out, shaming, or humiliating other members
- Sharing another member's personal information without consent

## 3. CONTENT STANDARDS

### 3.1 Permitted Content

- Sharing your own trading setups, journal entries, and progress updates
- Constructive feedback on other members' analysis

### 3.2 Prohibited Content

- Screenshots or redistribution of premium TradersKE signals outside community channels
- Promotion of competing services, other signal providers, or trading groups
- Explicit, adult, or offensive material
- Political discussions unrelated to market-moving events
- Spam, repeated messages, or excessive use of emojis/caps
- SCAM MESSAGES, PHISHING LINKS, OR FRAUDULENT INVESTMENT SCHEMES
- Unverified trading results presented as fact

## 4. TRADE IDEA ETIQUETTE

When discussing trade ideas — your own or those shared by TradersKE — please:

- Always acknowledge that all trade ideas carry risk
- Never pressure other members to follow any specific trade
- Do not blame TradersKE or other members when a trade does not work out
- Share your results honestly — wins AND losses contribute to community learning
- Do not share our premium signals in public groups, social media, or other channels

## 5. EVENTS AND COACHING ETIQUETTE

- Arrive on time for coaching sessions and events — late arrivals may forfeit their slot
- Come prepared with questions and chart examples for coaching sessions
- Do not record coaching sessions without prior written consent from TradersKE
- Behave professionally at in-person events — you represent the TradersKE community
  
- Follow venue rules at all physical event locations

## 6. ENFORCEMENT

### 6.1 Violation Consequences

Violations of these guidelines may result in:

- First offence (minor): formal warning via direct message
- Second offence or serious first offence: temporary suspension from community platforms
- Repeated or severe violations: permanent ban from all TradersKE platforms without refund
